A CRITICAL NEED FOR OPERATIONAL FUNDS OR THE SANCTUARY MAY CEASE TO EXIST

ANNOUNCING THE "WE ARE FOR THE BIRDS" DONATION DRIVE

Dear Friends;

As 2005 draws to a close, we look back on a remarkable achievement. Our dedicated staff & volunteers have worked tirelessly to rescue, rehabilitate, release & relocate injured, orphaned and sick native and migratory wild birds. Staff & volunteers have built many new and improved habitats for our resident, long term care birds.

The Pelican Man's Bird Sanctuary would like to thank all of our members, volunteers, donors, staff and the community for their continued support. Each wild bird that is rescued, rehabilitated, released, relocated, or provided with a permanent home, is because you cared enough to support the Sanctuary's efforts on a day-to-day basis.

Founded in 1981 by the late Dale Shields (b.1927-d.2003), affectionately nicknamed "the Pelican Man", the Pelican Man's Bird Sanctuary, the Wildlife Rehabilitation Hospital & Education Center, Sarasota, Florida, is one of the largest non-profit, wild bird rescue, rehabilitation, release, relocation & education centers in the U.S. and is totally dependent upon private donations & volunteers.

Since its'inception, the Sanctuary has been able to rescue & rehabilitate approximately 150,000 wild birds and return 90,000 back to their home.

As 2006 approaches and we enter our 25th year we wish to continue the Pelican Man's Bird Sanctuary mission however, we have reached a critical financial crossroads.

The rising costs of rehabilitation hospital care in combination with the impact of last year's hurricanes, the rising cost of fuel for rescues, continued loss of Thrift Store revenue, and a slow tourism season has depleted our day-to-day operational funds.

As the first step in a cost-saving action we have closed the Sanctuary's Thrift Stores in Sarasota & Venice. After holding clearance sales to generate needed cash flow, all remaining thrift store inventory has been donated to local charities.

The Pelican Man's Bird Sanctuary is developing its master plan for the future including improved & expanded rehabilitation hospital facilities & education programs, however, the future reality of those plans is totally dependent upon the immediate success in our ability to afford to operate the Sanctuary over the next few months.

Over the last few years we have had some generous donors who set aside dedicated funds to provide the Sanctuary with a start to our future Capital Campaign for new, expanded hospital facilities and related educational programs, however, these donations are not allowed to be used to offset our day-to-day operational costs.

His experience includes being the Museum Director of Explorers Hall for The National Geographic Society, Washington, D.C. and the Director of Long Range Planning

The New Heronry

Construction of the NEW Heronry, one of the most ambitious habitat re-construction projects at the Pelican Man's Bird Sanctuary, is well under way thanks to many donations including those from Nancy & Jim Curtis and the Sarasota Bay Parrot Heads. Soon to be the home of the Yellow-Crowned & Black-Crowned Night Herons, the Little Blue Heron, the Snowy Egrets, Cattle Egrets and White Ibis, the new Heronry will be one of the largest and most advanced habitats at the Sanctuary.

The new 1500 sq ft habitat is the result of merging four of the original Sanctuary habitats into one, and the focus will be on water & native wetland plants. It will be the first of the Sanctuary's habitats to utilize a water filtration system minimizing maintenance and disturbance to the birds. Construction is being undertaken by the Sanctuary's staff & volunteers as well as members of the ever-supportive Sarasota Bay Parrot Heads.

A HAWKISH VISITOR CAUSES A FRIGHT NIGHT



A juvenile Cooper's Hawk decided to take up residency at the Sanctuary, and caused panic among our long term care, resident 'small' birds. To the relief our smaller resident birds, the hawk was finally caught after days of trying by our wildlife rescuers and the bird was taken to an area near Myakka State Park, about 25-miles from the Sanctuary. However, to the consternation of our songbirds, the powerful Cooper's Hawk beat our rescue truck, back to the Sanctuary!

Fortunately for the resident songbirds, the Cooper's Hawk left on his own accord the following day.

THE COLOR PURPLE GOES BACK INTO THE WILD

A clutch of orphaned Purple Martins were rescued and brought to the Sanctuary by a caring person from Sarasota. The birds were fed by hand at regular intervals for two weeks until they were able to fly, when they were moved to a flight aviary. Here they had to learn how to feed on their own. Martins feed on the wing, and to help them, a low wattage light was installed to attract moths and other insects. Once we were sure that the birds were feeding on their own, they were returned to the wild.





OWL PARENTHOOD

A number of our long term care, resident birds earned their keep this year by becoming surrogate parents to a number of the rescued baby birds. Angie the American Crow, Rusty the Red-Tailed Hawk, and Lady Sophia & Bram the Ospreys all performed admirably and helped the young birds become aware of precisely who & what they were.

Perhaps the birds that deserve the most credit are our six Eastern Screech Owls who at one time were helping raise 15 baby Owls! Once the young Owls were released our resident birds were rewarded with an upgraded habitat.





ADOPT PELITHE PELICAN



Peli the Pelican lives in Habitat-20 after being found entangled in fishing line. Sadly the damage to her wing was such that she could not survive in the wild. She is the Sanctuary's mascot and the only bird available for Cooperative Adoption. 
